Total estate: \$1,000,000  
including \$200,000 in RRSP's

Plan without Charitable Gifts	Plan with Child called "Charity"
Income tax payable <b>\$100,000</b> <small>(approx. 1/2 of RRSP value)</small>	Income tax payable <b>\$0</b> <small>(depending on individual case)</small>
Amount to Charity <b>\$0</b>	Amount to Charity <b>\$200,000</b>
Amount to each child <b>\$225,000</b>	Amount to each child <b>\$200,000</b>




## Gift Distribution
